GRANT DEED

THIS INDENTURE, made this 26th day of June, 1978, by and between
 E & R INC. CORPORATION, a Nevada corporation, party of the first part, and
 BYRON L. and UVA D. HARRIS, husband and wife, as joint tenants, parties of
 the second part.

WITNESSETH:

That the said party of the first part, for and in consideration of the sum of TEN
 DOLLARS (\$10.00), lawful money of the United States, to first party in hand paid
 by the said parties of the second part, the receipt whereof is hereby acknowledged,
 does by these presents GRANT, bargain, sell and convey unto the said parties
 of the second part, with right of survivorship and to the survivor of them, as joint
 tenants, and not as tenants in common, their assigns, and to the heirs and assigns
 of the survivor thereof, all that certain lot, piece or parcel of land situate in the
 County of Eureka, State of Nevada, more particularly described as follows, to-wit:

Government Lots 9 and 10 of Section 29, Township 20 North, Range 53
 East, M. D. B. & M., together with well permit #25597, Certificate #7562,
 and a 30 foot easement due North from said well to the property line of Lot 9.

Together with all and singular the tenements, hereditaments and appurtenances
 thereunto belonging, or in anywise appertaining, and the reversion and reversions,
 remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD, all and singular the said premises, together with the
 appurtenances, unto the said parties of the second part, with right of survivorship
 and to the survivor of them, as joint tenants, and not as tenants in common, their
 assigns, and to the heirs and assigns of the survivor, forever.

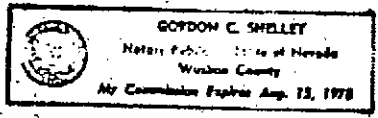
