

ASSIGNMENT OF UNDIVIDED INTERESTS
IN OIL AND GAS LEASES

THIS ASSIGNMENT, made and entered into as of this 14th day of April, 1978, by and between GETTY OIL COMPANY, a Delaware corporation, hereinafter called ("Getty Oil"), NORTH CENTRAL OIL CORPORATION, a Delaware corporation, hereinafter called ("North Central"), and AMOCO PRODUCTION COMPANY, a corporation, hereinafter called ("Amoco"),

W I T N E S S E T H:

WHEREAS, Getty Oil is the owner of an undivided 50% working interest, North Central is the owner of an undivided 41-2/3% working interest and Amoco is the owner of an undivided 8-1/3% working interest in and under those certain Oil and Gas Leases, hereinafter called ("said leases"), covering those certain lands situated in Eureka County, Nevada, particularly described in Exhibit "A", attached hereto and by this reference incorporated herein and made a part hereof, and

WHEREAS, Getty Oil and North Central desire to assign an undivided interest in said leases to Amoco so that each of the parties shall hereafter own an undivided one-third interest in said leases,

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency are hereby acknowledged, Getty Oil hereby assigns an undivided 16-2/3% interest in said leases unto Amoco and North Central hereby assigns an undivided 8-1/3% interest in said leases to Amoco.

The foregoing assignment is subject to the following overriding royalties:

2-3/4% of 100% of the production, previously reserved by M. Peyton Bucy,

1% of 100% of production, previously reserved by General Crude Oil Company, and

1/4 of 1% of 100% of production previously reserved by AGM Corporation.

The aforesaid Bucy and General Crude Oil overriding royalties shall be equally borne and paid by Getty Oil, North Central Oil Corporation and Amoco; however, the AGM overriding royalty shall be borne and paid solely by Amoco.

By its execution hereof, Amoco does hereby accept this assignment and agrees to abide by and perform all of the duties of the lessee insofar as applicable to the interests herein assigned to Amoco.

IN WITNESS the parties have executed this Assignment of Undivided Interests of Oil and Gas Leases as of the date hereinabove mentioned.

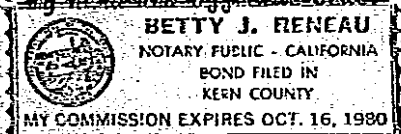
