The Claim is 1500 feet long and 500 feet wide, such that 50 feet is claimed in a South direction and 1450 feet in a North direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 250 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the North to the South direction.
