AFFIDAVIT OF STATEMENT OF ANNUAL ASSESSMENT
(PROOF OF LABOR)
WORK ON UNPATENTED LODE MINING CLAIMS
FOR ASSESSMENT YEAR ENDING SEPT. 1, 1978

PROOF OF LABOR ON THE GOLDEN BOY NO. 1, GOLDEN BOY NO. 2, GOLDEN BOY NO. 3, GOLDEN BOY NO. 4, GOLDEN BOY NO. 5, GOLDEN BOY NO. 13, GOLDEN BOY NO. 14, GOLDEN BOY NO. 15, GOLDEN BOY NO. 16, GOLDEN BOY NO. 17, AND GOLDEN BOY NO. 18, CONTIGUOUS LODE MINING CLAIMS LOCATED IN SEC. 18, TWP. 35 N., R. 51 E., MT. DIABLO MERIDIAN, EUREKA COUNTY, STATE OF NEVADA.

Jack M. Ahearn, a Registered Engineer and Land Surveyor of the State of Utah reports that the assessment work for the assessment year ending Sept. 1, 1978 was performed and made for the foregoing Lode Mining Claims, situated in Sec. 18, Twp. 35 N., R. 51 E., NDM., Eureka County, Nevada.

That during the assessment year ending Sept. 1, 1978 at least \$1100.00 worth of labor was performed and made on, or for the benefit of, the contiguous Lode Mining Claims included in the aforementioned groups. That such labor and improvements consisted of the performance of a magnetic survey near the surface with a handheld proton magnetometer. These readings were performed on the corners of a grid contained in a square which is described as follows: beginning at a point on Golden Boy No. 13 lode mining claim, from which the east quarter corner monument of Sec. 18, T. 35 N., R. 51 E., NDM. bears east a distance of 3440 feet; thence south a distance of 1040 feet to the southwest corner of the subject square; thence east a distance of 220 feet to the point of discovery on the Golden Boy No. 13 lode mining claim; thence east 600 feet to the point of discovery on Golden Boy No. 14 lode mining claim; thence east 220 feet to the southeast corner of the subject square; thence north 1040 feet to the northeast corner of the subject square; thence west 1040 feet to the point of beginning. This square is divided so as to precisely contain a grid composed of 100 squares, and readings were taken at the intersections of the said grid to produce 121 stations. The values thus obtained were adjusted and plotted on a topographic map. The diagram so formed from these readings will be used to compliment existing work.

All of the above work was done at the request of, and on behalf of, Robert B. Mee, a resident of Salt Lake County, State of Utah, whose mailing address is Box 1117, Salt Lake City, Utah 84147.

That said work was performed and expenditures made for the purpose of complying with the laws of the United States and of the State of Nevada pertaining to Annual Assessment work. All of said claims are contiguous and all work was performed as part of a common over-all program for the mutual and individual benefit of said claims. Said work was done, and expenditures made, during the months of February and August, 1978.

To comply with Federal law relating to the performance of geophysical surveys, to satisfy annual labor requirements for lode mining claims, Jack M. Ahearn, affiant, further states that he is currently registered as a Professional Engineer in the State of Utah, No. 922, that he has been professionally engaged in geophysical surveys for more than 20 years, that he holds a Master of Science degree from the University of Oregon, and that he is competent to perform and interpret the geophysical survey outlined in the preceding.
