five (5) Taking bulk ore samples (at least 75 pounds) from the main pit on the Bear group of contiguous claims located on the Bear #2 claim. These samples were taken to testing laboratory of Chromalloy American Corporation at the Jungle Millsite north of Wells, Nevada where they were crushed and screened. Upon crushing and screening, ~~ten (10)~~ separate heavy liquid separation tests were run on the screened materials to determine the quality of the barite ores and most beneficial methods of recovery. Upon separation, specific gravity tests were completed and the work reported.
