ASSIGNMENT OF UNDIVIDED INTERESTS IN OIL AND GAS LEASE

THIS ASSIGNMENT, made and entered into as of the 14th day of April, 1978, by and between GETTY OIL COMPANY, a Delaware corporation, hereinafter called ("Getty Oil"), NORTH CENTRAL OIL CORPORATION, a Delaware corporation, hereinafter called ("North Central") and AMOCO PRODUCTION COMPANY, a corporation, hereinafter called ("Amoco"),

WHEREAS, Getty Oil is the owner of an undivided 50% working interest, North Central is the owner of an undivided 41-2/3% working interest and Amoco, an undivided 8-1/3% working interest in and under that certain Oil and Gas Lease dated July 15, 1975, by and between Southern Pacific Land Company, Lessor, and M. Peyton Bucy, Lessee, recorded in Book 54, Page 334, of the records of Eureka County, Nevada, and in Book 233, Page 460 of the records of Elko County, Nevada, as amended by that certain Amendment to Oil and Gas Lease dated November 29, 1976, recorded in Book 60, Page 96 of the records of Eureka County, Nevada, and Book 248, Page 392 of the records of Elko County, Nevada; said lease, as amended, covering lands situated in Eureka and Elko Counties, Nevada, as more particularly described in Exhibit "A", attached hereto and by this reference incorporated herein and made a part hereof, and

WHEREAS, Getty Oil and North Central desire to assign an undivided interest in said lease unto Amoco so that each of the parties shall hereafter own an undivided 1/3% interest in said lease, and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Getty Oil hereby assigns an undivided 16-2/3% interest in said lease unto Amoco and North Central hereby assigns an undivided 8-1/3% interest in said lease unto Amoco.

The foregoing assignment is subject to the following overriding royalties:

1% of 100% of the production, previously reserved by M. Peyton Bucy, and

1/4 of 1% of 100% of production previously reserved by AGM Corporation.

The aforesaid Bucy overriding royalty shall be equally borne and paid by Getty Oil, North Central Oil Corporation and Amoco; however, the AGM overriding royalty shall be borne and paid solely by Amoco.

By its execution hereof, Amoco does hereby accept this assignment and agrees to abide by and perform all of the duties of the lessee insofar as applicable to the interests herein assigned to Amoco.
