THIS INDENTURE, made and entered into this 20<sup>th</sup> day of October, 1978, by and between MARJORY ANN PASTORINO, a widow, and DAVID PASTORINO, her son, both of Eureka, Nevada, Grantors, and PHILIP R. BROWN and LINDA L. BROWN, husband and wife of Eureka, Nevada, in joint tenancy with right of survivorship, Grantees.

W I T N E S S E T H :

That the Grantors, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, to them in hand paid by the Grantees, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said Grantees as joint tenants with right of survivorship and not as tenants in common, and to the survivor of them, and to the heirs, executors, administrators and assigns of the survivor, all that certain real property situate in the Town of Eureka, County of Eureka, State of Nevada, and more particularly described as follows, to-wit:

A portion of the "Old Railroad Grade" described as: Beginning at the Southwest Corner of Lot 6, Block 39B, thence S. 81°54'08" W., 25.80 feet to the Southeast Corner of Lot 6, Block 39C, thence N. 01°01'00" W., 25.47 feet to the Northeast Corner of Lot 6, Block 39C, thence N. 82°28'27" E., 15.72 feet, thence N. 01°09'15" W., 101.20 feet, thence S. 05°41'04" E., 125.68 feet to the point of beginning and containing .024 acres more or less of the Old Railroad Grade of the Townsite of Eureka, Nevada.

TOGETHER WITH all improvements situate thereon.

TOGETHER WITH the tenements, hereditaments, and appurtenances thereunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

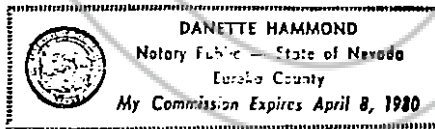
