

## CERTIFICATE OF LOCATION OF LODE MINING CLAIMS

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the JKT 12 lode mining claim in the SW quarter of Section 33, Township 23 North, Range 48 East, of the Mount Diablo Meridian, in an unorganized mining district, of Eureka County, in the State of Nevada, on the 29th day of September, 1978, for NL Industries, Inc., 5926 McIntyre St., Golden, Colorado 80401.

The claim is 1500 feet long and 600 feet wide and 20 feet is claimed in a N. 0°13' E. direction along the length of the claim and 1480 feet is claimed in a S. 0°13' W. direction along the length of the claim from the Location Mounument at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a N. 0°13' E. and S. 0°13' W. direction.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location and markings on each boundary or corner monument is as follows:

As erected on the ground each boundary or corner monument is marked as described above by aluminium tag attached to the monument.

The monumentation and marking of the above mentioned corners on the ground was completed by the 5th day of October, 1978 and the location work consisted of making a claim map as provided in NRS. 517.040. Two copies of this map are filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
