IT APPEARING, that the Defendant, RONALD NAILLON, above named, having failed to answer within the time required by law, and the default of said Defendant having been duly entered for failure to appear and answer, and

IT FURTHER APPEARING, that Plaintiff's action is based upon contract and is for the recovery of money and damages only;

IT FURTHER APPEARING, that service of Summons was made upon the Defendant on August 4, 1978, in the County of Eureka State of Nevada, and said Defendant has failed to appear or otherwise answer the Complaint; the Plaintiff has been compelled to employ counsel and incur costs herein, and that the Plaintiff is entitled to a reasonable attorney fee.

NOW, THEREFORE, IT IS HEREBY ORDERED, that Plaintiff have judgment against Defendant, RONALD NAILLON in the sum of ONE THOUSAND FOUR HUNDRED FORTY-FOUR DOLLARS AND FORTY-THREE CENTS (\$1444.43), together with interest thereon at the rate of SEVEN (7) percent per annum on the unpaid balance from July 26, 1977, until paid, plus Plaintiff's cost of suit in the sum of FIFTY-FIVE DOLLARS (\$55.00), and a reasonable attorney's fee of FOUR HUNDRED
