The Claim is 1500 feet long and 600 feet wide, such that 20 feet is claimed in a SOUTHEASTERLY direction and 1480 feet in a NORTHWESTERLY direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the SOUTHEASTERLY to the NORTHWESTERLY direction.
