CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the MH # 552 Lode Mining Claim on this 30th day of November, 1978, situated in the Mt. Hope Mining District, Eureka County, Nevada.
