CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the MH # 711 Lode Mining Claim on this 20th day of November, 1978, situated in the Mt. Hope Mining District, Eureka County, Nevada.

Said Claim is located in the SW (Quarter) Section(s) 22 Township 22 North, Range 52 East, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a Southerly direction to Post No. 2,
- Thence, 750 feet in a Westerly direction to Post No. 3,
