CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the MH # 715 Lode Mining Claim on this 28th day of November, 1978, situated in the Mt. Hope Mining District, Eureka County, Nevada.

Said Claim is located in the NW & SW (Quarter) Section(s) 22 Township 22 North, Range 52 East, Mt. Diablo P.M., and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1,

- Thence, 600 feet in a Southerly direction to Post No. 2,
