ORDER GRANTING APPLICATION SEEKING RECLAMATION OF PROPERTY

The primary secured creditor for the above-entitled bankrupt, PRODUCERS LIVESTOCK LOAN COMPANY, filed an Application Seeking Reclamation of Property on November 14, 1978. The Bankrupt and other interested creditors were given notice that the Application Seeking Reclamation of Property would be held on December 6, 1978 at 11 A.M. The hearing on said Application of the secured creditor was held on December 6, 1978 at 11 A.M. At the same time, testimony was taken from MARCUS SKEEM with reference to his Objection to Petition for Reclamation and Claim. Mr. Skeem testified that he was owed THIRTY FOUR THOUSAND NINE HUNDRED SEVENTEEN DOLLARS AND SEVENTY-SIX CENTS (\$34,917.76) representing the balance due and owing for SKEEM to cut, bale and stack TWO THOUSAND ONE HUNDRED EIGHTY TWO POINT THIRTY SIX (2182.36) tons of hay for the bankrupt. 1 Mr. Skeem that there should be a debit against said sum of money
2 in the amount of ONE HUNDRED TWENTY FIVE DOLLARS (\$125.00) for
3 machinery parts tendered to SKEEM by the bankrupt.

4 The Court found from the testimony of SKEEM that the
5 services rendered benefited the bankrupt's property and the
6 property that the secured creditor seeks to reclaim. Additionally,
7 the Court found that the bankrupt's property was not burdened by
8 reason of the services SKEEM rendered.

9 Good cause appearing and upon the oral opinion of the
10 Court, IT IS ORDERED that the application of PRODUCERS LIVESTOCK
11 LOAN COMPANY for the reclamation of real and personal property
12 be granted, and that PRODUCERS LIVESTOCK LOAN COMPANY be allowed

15 IS FURTHER ORDERED that the claim of MARCUS SKEEM in the amount of
16 THIRTY FOUR THOUSAND NINE HUNDRED SEVENTEEN DOLLARS AND SEVENTY-
17 SIX CENTS (\$34,917.76), minus ONE HUNDRED TWENTY FIVE DOLLARS
18 (\$125.00), for a total of THIRTY FOUR THOUSAND SEVEN HUNDRED
19 AND NINETY-TWO DOLLARS AND SEVENTY-SIX CENTS (\$34,792.76), is
20 allowed as an expense of administration and that said claim in
21 the amount of THIRTY FOUR THOUSAND SEVEN HUNDRED AND NINETY-TWO
22 DOLLARS AND SEVENTY-SIX CENTS (\$34,792.76) is to be paid by *fly*
23 PRODUCERS LIVESTOCK LOAN COMPANY and is to be a charge against
