## DEED TO MINING CLAIM QUITCLAIM

The Silverado #11 Lode Mining Claim in Section 11, Township 18N, Range 53E in the Eureka Mining District, in Eureka County, in the State of Nevada.

TOGETHER with all the Dips, Spurs and Angles, and also all the minerals, metals, ores, gold and silver bearing quartz, rock and earth and all other minerals therein; and all the rights, privileges and franchises thereto incident, appendant and appurtenant, or therewith usually had and enjoyed; and also, all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining, the rents, issues and profits thereof; and also the estate, right, title, interest, property possession, claim and demand whatsoever, as well in law as in equity, of the said party Y of the first part, of, in or to the said premises, and every part and parcel thereto with the appurtenances,

TO HAVE AND TO HOLD, all and singular the said premises, together with the appurtenances and privileges thereunto incident, unto said party Y of the second part.

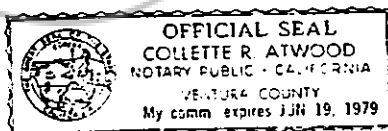
