

CERTIFICATE OF LOCATION OF LODE MINING CLAIMS

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the RUS 15 lode mining claim in the SW quarter of Section 20, Township 27 North, Range 48 East, and the NW quarter of Section 20, Township 27 North, Range 48 East, and the SE quarter of Section 19, Township 27 North, Range 48 East, and the NE quarter of Section 19, Township 27 North, Range 48 East, of the Mount Diablo Meridian, in the Cortez mining district, of Eureka County, in the State of Nevada, on the 22nd day of January, 1979, for Allen Russell, P.O. Box 648, Beowawe, Nevada 89821.

The claim is 1500 feet long and 600 feet wide and 1480 feet is claimed in a N.11°W. direction along the length of the claim and 20 feet is claimed in a S.11°E. direction along the length of the claim from the Location Monument at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a N.11°W. and S.11°E. direction.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location and markings on each boundary or corner monument is as follows:

As erected on the ground each boundary or corner monument is marked as described above by an aluminium tag attached to the monument.

The monumentation and marking of the above mentioned corners on the ground was completed by the 22nd day of January, 1979 and the location work consisted of making a claim map as provided in NRS. 517.040. Two copies of this map are filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
