GRANT, BARGAIN AND SALE DEED

THIS INDENTURE, made and entered into as of the 15th day of February, 1979, by and between BATTISTA TOMERA, JR., and GEORGE TOMERA, of the County of Elko, State of Nevada, First Parties; and RAND & SON, INC., a Nevada Corporation, of the same place, Second Party;

W I T N E S S E T H:

That the said First Parties, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful, current money of the United States of America, to them in hand paid by the said Second Party, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell, convey and confirm unto the said Second Party, and to its successors and assigns, all that certain real property situate, lying and being in the County of Eureka, State of Nevada, more particularly described as follows:

A triangular tract of land lying in Sections 10 and 15, Township 30 North, Range 51 East, M.D.B.&M. Eureka County, Nevada, being more particularly described as follows:
