the grantor does hereby grant, bargain, convey, and confirm unto the United States of America can easement and right-of-way over the tract, lot, piece, or parcel of land situated, lying and being in the County of Lureka, more particularly described as follows:

Beginning at a point 546 feet north of the SW Cor. Sec. 7 Township 31 North, Range 50 East, Mt. Diablo Meridian; thence 20 feet east; thence 40 feet north; thence 20 feet west; thence 40 feet south along the section line to the point of beginning.

The easement and right-of-way hereby granted is for the full, free, unrestricted, and quiet use and enjoyment by the grantee of the land of the grantor occupied by the said improvements for any and all purposes deemed necessary or beneficial for, or in connection with, the control, administration, or use of the public land surrounding or adjacent to the land herein described, which may be properly grazed from, serviced by, or used in connection with the said land and improvements, including the right of ingress and egress to, from, and over the land of the grantor by the grantee, its officers, agents, permittees, allottees, and licensees for the purpose of repairing, renewing, or using the said im-

provements, or for other business pertaining to the use and maintenance thereof, and shall be appurtenant to said public land.

This grant shall be effective so long as the easement shall be actually used for the aforesaid purposes, and all rights hereunder shall revert to the grantor when and in the event the use thereof shall be discontinued or abandoned by the grantee of which due notice shall be given to the grantor by the grantee. Upon termination or abandonment of this easement, the grantee may at its option and within reasonable time, remove any improvements constructed by grantee on the land hereunder.
