The general course of the lode deposit and premises is from the SOUTHERLY to the NORTHERLY.

Corner No. 5 is a 4" x 4" x 4 1/2 FT WOODEN POST MARKED S.W. COR. BEAR#6

Corner No. 6 is a 4" x 4" x 4 1/2 FT WOODEN POST MARKED W.S. COR. BEAR#6

The monumentation and marking of the corners was completed by the 15TH day of MARCH, 1979.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
