The general course of the lode deposit and premises is from the NORTHERLY to the SOUTHERLY.

Corner No. 5 is a 4"x4"x9 1/2 FL WOODEN POST MARKED W.S.C. BEAR #14

Corner No. 6 is a 4"x4"x9 1/2 FL WOODEN POST MARKED E.S.C. BEAR #14

The monumentation and marking of the corners was completed by the 30<sup>TH</sup> day of MARCH, 1979.
