

Certificate of Location of Lode Mining Claim

The claim is 1500 feet long and 600 feet wide, and 1980 feet is claimed in a NORTHERLY direction and 20 feet in a SOUTHERLY direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the NORTHERLY to the SOUTHERLY.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by MARKING THE CLAIM POST WITH KEEL

Corner No. 3 is a 4" x 4" x 4 1/2 FT WOODEN POST MARKED N.E. COR BEAR#19

Corner No. 4 is a 4" x 4" x 4 1/2 FT WOODEN POST MARKED N.W. COR BEAR#19

Corner No. 5 is a 4" x 4" x 4 1/2 FT WOODEN POST MARKED E.S.C. BEAR#19

Corner No. 6 is a 4" x 4" x 4 1/2 FT WOODEN POST MARKED W.S.C. BEAR#19

The monumentation and marking of the corners was completed by the 19th day of APRIL, 1929.

(Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.

NRS 517.300, Subsection 2.
