TO HAVE AND TO HOLD the said premises, together with the appurtenances unto the party of the second part, and to its successors and assigns, forever.

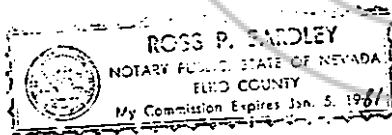
