The general course of the lode deposit and premises is from the NORTHERLY to the SOUTHERLY.

Corner No. 5 is a 4" x 4" x 9 1/2' FE WOODEN POST MARKED E.S.C. L & R #6  
Corner No. 6 is a 4" x 4" x 9 1/2' FE WOODEN POST MARKED N.E. COR L & R #6

The monumentation and marking of the corners was completed by the 28<sup>th</sup> day of APRIL, 1979.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
