The general course of the lode deposit and premises is from the NORTHERLY to the SOUTHERLY.

Corner No. 5 is a 4"x4"x4 1/2" FL WOODEN POST MARKED W.S.C. L & R #7

Corner No. 6 is a 4"x4"x4 1/2" FL WOODEN POST MARKED N.W. COR. L & R #7

The monumentation and marking of the corners was completed by the 28th day of APRIL, 1979.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
