Corner No. 5 is a 4" x 4" x 4 1/2" FT WOODEN POST MARKED N.E. COR. L & R #8

Corner No. 6 is a 4" x 4" x 4 1/2" FT WOODEN POST MARKED N.W. COR. L & R #8

The monumentation and marking of the corners was completed by the 28th day of APRIL, 1979.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
