7 That the GRANTOR, for and in consideration of a land
8 trade of equitable value, the receipt whereof is hereby acknowledged,
9 does by these presents hereby grant, bargain and sell unto the said
10 GRANTEE, and to its successors and assigns forever, all that
11 certain lot, piece or parcel of land situate, lying and being in
12 the County of Eureka, State of Nevada, more particularly described
13 as follows, to-wit:

14 A parcel of land in the SW 1/4 NW 1/4 of Section 24,

18 Beginning at angle point 6 of the Southern Cross
19 Millsite monumented by an iron post and brass cap
20 marked U.S.G.L.O. AP6 100B SCM 1936 from which the
21 1/4 section corner common to Sections 23 and 24,
22 T. 19 N., R. 53 E., M.D.M. bears South 46°34'1"
23 West 624.59 feet; thence along the southerly
24 boundary of the Southern Cross Millsite North
25 52°26'13" East 90.95 feet to the angle point 5 of
26 the Southerly Cross Millsite monumented by an iron
27 post and brass cap marked U.S.G.L.O. P5 100B SCM
28 1936; thence along the southerly boundary of the
29 Southern Cross Millsite South 45°6'38" East 270.57
30 feet to angle point 8 of the Geraldine Millsite
31 monumented by an iron post and brass cap marked
32 U.S.G.L.O. AP8 284B GM 1936; thence North 62°48'39"
West 296.56 feet to the place of beginning,


