

PARTIAL RECONVEYANCE

FIRST NATIONAL BANK, a corporation, as Trustee, does hereby quitclaim and reconvey unto PATRICIA McCULLOCH and WILLIAM H. McCULLOCH, without any warranty, all of the right, title and interest of said Trustee in the hereinafter described portion of the land described in the Deed of Trust executed by WAYNE D. Beginning at angle point 6 of the Southern Cross Millsite monumented by an iron post and brass cap marked U.S.G.L.O. AP6 100B SCM 1936 from which the 1/4 section corner common to Sections 23 and 24, T. 19 N., R. 53 E., M.D.M. bears South 46°34'1" West 624.59 feet; thence along the southerly boundary of the Southern Cross Millsite North 52°26'13" East 90.95 feet to the angle point 5 of the Southerly Cross Millsite monumented by an iron post and brass cap marked U.S.G.L.O. P5 100B SCM 1936; thence along the southerly boundary of the Southern Cross Millsite South 45°6'38" East 270.57 feet to angle point 8 of the Geraldine Millsite monumented by an iron post and brass cap marked U.S.G.L.O. AP8 284B GM 1936; thence North 62°48'39" West 296.56 feet to the place of beginning, containing 0.2800 acres, more or less.

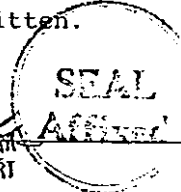
