MEMORANDUM OF MINING AGREEMENT WITH OPTION TO PURCHASE

1,

Bisoni (man and wife) and Maynard and Mary Bisoni (man and wife) (therein and hereinafter referred to as "Optionor"), and AMSELCO MINERALS INC., a Delaware corporation, (therein and hereinafter referred to as "Optionee"), have entered into a Mining Agreement with Option to Purchase ("Agreement") dated the 15th day of April, 1979, with respect to the mining claims described in Exhibit A attached hereto and by this reference made a part hereof and which claims are therein and hereinafter referred to as the "Subject Premises".

Optionee shall have the right to use such resources of the Subject Premises -- including, but not limited to, timber and water -- as Optionee in its sole discretion deems advisable in connection with its exploration, development, mining and construction operations on the Subject Premises.

In addition, under the terms of the Agreement, Optionor has granted and hereby grants to Optionee for a period ending at Midnight (Pacific Standard Time) on April 15, 1988, the sole, exclusive and irrevocable option to purchase the Subject Premises, all upon the terms and conditions set forth in the Agreement.

Any assignment of interest under the Agreement and this Memorandum of Agreement shall be made expressly subject to the Agreement and shall require the assignee to assume and agree in writing to perform all the obligations of the assignor under the Agreement as relate to the interest assigned. In case of assignment by mortgage, however, such assumption of obligations shall not be required, but should such mortgage be foreclosed, the purchaser on foreclosure shall take subject to the Agreement. The provisions of the Agreement and this Memorandum of Agreement shall inure to the benefit of and be binding upon the parties and their heirs, executors, administrators, personal representatives, beneficiaries, successors and assigns. No assignment shall be effective as between the parties until the first day of the next month following the delivery to the non-assigning party of satisfactory evidence of such assignment.
