 27 ders, rents, issues and profits thereof.

 29 together with the appurtenances, unto the said party of the sec-
 30 ond part, her heirs and assigns forever.

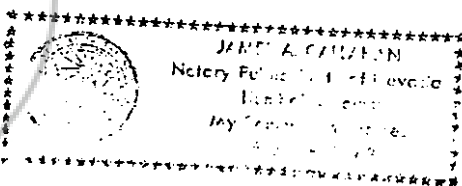
