

Certificate of Location of Lode Mining Claim

The claim is 1500' feet long and 600' feet wide, and 750' feet is claimed in a southerly direction and 750' feet in a northerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300' feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the West to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by PAPER inserted into 4x4 post

Note 2: "Every person who willfully and knowingly makes a false material statement on the location certificate or on any map required by this chapter shall be guilty of a felony, and upon conviction thereof shall be imprisoned in the state prison for not less than 3 years nor more than 10 years." NRS 517.300, Subsection 2.
