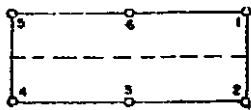
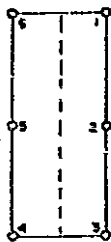

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the under-

 Dated June 9, A.D., 1979, and filed in duplicate.

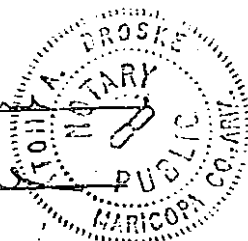
