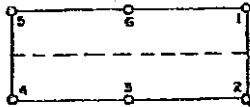

signed, does hereby locate the MC. 4 Lode Mining Claim on this

District, Eureka County, Nevada.

Said Claim is located in the SE (Quarter) Section(s) 36
Township 24, Range 48 E., Mt. Diablo P.M., and more particularly
described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a Southerly direction to Post No. 2,
Thence, 750 feet in a Southerly direction to Post No. 3,
Thence, 600 feet in a Westerly direction to Post No. 4,
Thence, 750 feet in a Northerly direction to Post No. 5,
