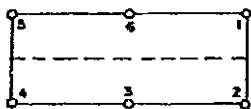
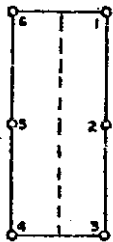

## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the under-  
signed, does hereby locate the MC. 10 Lode Mining Claim on this  
24 day of May, 1979, situated in the Unknown Mining  
District, Eureka County, Nevada.

Said Claim is located in the SW-SE (Quarter) Section(s) 36,  
Township 24, Range 48 E., Mt. Diablo P.M., and more particularly  
described as follows, to wit:

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a Southerly direction to Post No. 2,  
Thence, 750 feet in a Southerly direction to Post No. 3,  
Thence, 600 feet in a Westerly direction to Post No. 4,  
Thence, 750 feet in a Northerly direction to Post No. 5,  
Thence, 750 feet in a Northerly direction to Post No. 6,

the point of beginning and all posts being 4" x 4" x 5'.
