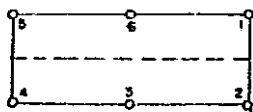
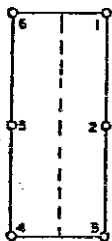

## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the under-  
 signed, does hereby locate the MC. 14 Lode Mining Claim on this

 District, Eureka County, Nevada.
