 Claim.

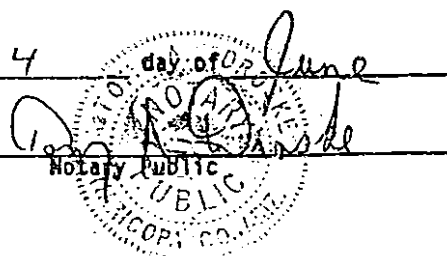
