

CERTIFICATE OF LOCATION LODE MINING CLAIM (NEVADA)

Notice is hereby given that PHELPS DODGE CORPORATION, whose address is 1601 Vassar Street, Reno, Nevada 89502, by its undersigned agent, makes this location of the Faith No. 137 lode mining claim in the Montgomery

Mining District Eureka County(ies), Nevada. This claim was located and the notice of location was posted on 24<sup>th</sup> day of May, 1979.

From the discovery monument, the undersigned claims 10 feet running in a Westerly direction and 1490 feet running in a Easterly direction lengthwise of the claim together with 300 feet in width on each side of the center of the lode or vein. The general course of said lode or vein is from the West to the East. This claim is 1500 feet in length and 600 feet in width.

The discovery monument, at which the notice of location is posted, is located approximately 7,694 feet North and 7,177 feet East from the Southwest Corner of Section 19 T. 18 N., R. 54 E., M.D.B. & M., and said claim is located within the NW 1/4, NE 1/4, SW 1/4, SE 1/4, of Section(s) 17 T. 18 N., R. 54 E., M.D.B. & M.

If not otherwise specified, there are 7 posts at least 4in. in diameter by 4½ ft. in length set 1 ft. in the ground, one for the discovery monument, one for each of the four corners and one at the center of each side line, which posts or monuments were erected on June 1, 1979.
