

## CERTIFICATE OF LOCATION OF LODE MINING CLAIMS

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the Pill 23 lode mining claim in the NE quarter of Section 29, Township 28 North, Range 52 East, and the SE quarter of Section 29, Township 28 North, Range 52 East, and the NW quarter of Section 29, Township 28 North, Range 52 East, and the SW quarter of Section 29, Township 28 North, Range 52 East, of the Mount Diablo Meridian, in an unknown mining district, of Eureka County, in the State of Nevada, on the 25th day of June, 1979, for Occidental Minerals Corporation, Irongate Bldg. 4, 777 S. Wadsworth Blvd., Lakewood, Colorado 80226.

The claim is 1452 feet long and 600 feet wide and 20 feet is claimed in a North direction along the length of the claim and 1432 feet is claimed in a South direction along the length of the claim from the Location Monument at which the Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a North and South direction.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location and markings on each boundary or corner monument is as follows:

As erected on the ground each boundary or corner monument is marked as described above by an aluminum tag attached to the monument.

The monumentation and marking of the above mentioned corners on the ground was completed by the 6th day of July, 1979 and the location work consisted of making a claim map as provided in NRS. 517.040. Two copies of this map are filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
