

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the Pipp 21 placer mining claim in the NW quarter of Section 29, Township 28 North, Range 52 East, and the SW quarter of Section 29, Township 28 North, Range 52 East, of the Mount Diablo Meridian, in an unknown mining district, of Eureka County, in the State of Nevada, on the 25TH day of June, 1979, for Occidental Minerals Corporation, Irongate Bldg. 4, 777 S. Wadsworth Blvd., Lakewood, Colorado 80226.

Beginning at Corner No. 1, being the Northeast corner and location monument at which the Location Notice is posted for said Pipp 21 placer claim; thence 726 feet in a South direction to Corner No. 2, being the East side center monument; thence 726 feet in a South direction to Corner No. 3, being the Southeast corner monument; thence 600 feet in a West direction to Corner No. 4, being the Southwest corner monument; thence 726 feet in a North direction to Corner No. 5, being the West side center monument; thence 726 feet in a North direction to corner No. 6, being the Northwest corner Monument; thence 600 feet in an East direction to Corner No. 1, and place of beginning; containing 20 acres.

As erected on the ground each boundary or corner monument is marked as described above by an aluminum tag attached to the monument.

The monumentation and marking of the above mentioned corners on the ground was completed by the 9th day of July, 1979 and the location work consisted of making a claim map as provided in NRS. 517.100. Two copies of this map are filed with the Eureka County Recorder, and the \$1.00 per acre placer claim filing fee has been paid to the County Recorder.
