**CERTIFICATE OF LOCATION

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Quest No. 28 Lode Mining Claim in the following quarter section(s): SW 1/4 and SE 1/4 of Section(s) 18, Township 34 N, Range 52 E, M.D.B. & M., in the Maggie Creek Mining District, in Eureka County, in the State of Nevada, on the 13 day of June, 1979.

The Claim is 1700 feet long and 600 feet wide, such that 50 feet is claimed in a north direction and 650 feet in a south direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the north to the south direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 22 day of June, 1979.
