The undersigned hereby certifies (certify) that he (she, they) has (have) located the Gladiator 5 Lode Mining Claim in the following quarter section(s): NE 1/4 & NW 1/4 of Section(s) 16, Township 33N, Range 51E, M.D.B. & M., in the Noggin Creek Mining District, in Eureka County, in the State of Nevada, on the 25 day of JUNE, 1979.

The general course of the lode deposit and premises is from the north to the south direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments, and the marking of such monuments was completed by the 10 day of July, 1979.
