The Claim is 1500 feet long and 400 feet wide, such that 1200 feet is claimed in a South direction and 300 feet in a North direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the discovery monument and centerline of the claim. The general course of the lode deposit and premises is from the North to the South direction.
