

AFFIDAVIT OF PERFORMANCE OF ANNUAL LABOR

M. Craig Haase, being first duly sworn upon his oath, deposes and says: he is a citizen of the United States of America and more than twenty-one (21) years of age; he resides in the County of Washoe, State of Nevada; he is personally acquainted with those certain unpatented mining claims situate in the Buckhorn Mining District, Eureka County, Nevada, the names of which in the books and pages of the records in the office of the County Recorder of Eureka County, Nevada, wherein the location certificates thereof are recorded are Buckaroo Numbers 1 through 175, Book 61, Pages 395 to 571.

The foregoing 175 unpatented lode mining claims are all contiguous. Said claims are subject to a lease from Buckhorn Mines Co., to Bar Resources, Inc. Affiant is retained by Bar Resources, Inc., to oversee the legal affairs of said company and is duly authorized to make this affidavit for Bar Resources, Inc., with respect to the above-identified Buckaroo claim group.

Between the first day of September, 1978 and the last day of July, 1979, more than SEVENTEEN THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$17,500.00) worth of work and improvements were done and performed upon and for the benefit of said mining claims, not including the location work on said claims, as hereinafter is more particularly set forth.

Said work and improvements were done and performed by Bar Resources, Inc., a Nevada corporation, and were done and performed at the expense of Bar Resources, Inc., for the lessor, Buckhorn Mines Co., with regard to the entire Buckaroo group of claims. Said work and improvements so done and performed comply with the laws of the United States of America and the State of Nevada pertaining to assessment work or annual labor for the annual assessment year ending at noon, September 1, 1979, and said work was performed for the benefit of said mining claims for the purpose of exploration and development of the said mining claims. The following is a description of the work done, to-wit: a mill, refinery, and processing plant was built and constructed for the purpose of processing ores from the said claims; a series of mine roads to and from said claims and the associated mill and refinery was constructed and a drilling program was conducted with respect to said mining claims for the purpose of establishing ore reserves contained within said mining claims; numerous metallurgical examinations and experiments were conducted with respect to the ore contained on said mining claims.

The claim maps showing the above-identified mining claims are filed as Document Numbers 64072 and 64144 with regard to the Buckaroo group of claims in the official records of the Eureka County Recorder, State of Nevada.
