

CERTIFICATE OF LOCATION LODE MINING CLAIM (NEVADA)

From the discovery monument, the undersigned claims 1490 feet running in a Southerly direction and 10 feet running in a Northerly direction lengthwise of the claim together with 300 feet in width on each side of the center of the lode or vein. The general course of said lode or vein is from the North to the South. This claim is 1500 feet in length and 600 feet in width.

The discovery monument, at which the notice of location is posted, is located approximately 60 feet North and 14,067 feet West from the Southeast Corner of Section 15 T. 23 N., R. 51 E., M.D.B. & M., and said claim is located within the SW 1/4, NW 1/4, 1/4, 1/4, of Section(s) 17/20 T. 23 N., R. 51 E., M.D.B. & M.
