

CERTIFICATE OF LOCATION LODE MINING CLAIM (NEVADA)

Notice is hereby given that PHELPS DODGE CORPORATION, whose address is 1601 Vassar Street, Reno, Nevada 89502, by its undersigned agent, makes this location of the BAR No. 54 lode mining claim in the Unknown

Mining District Eureka County(ies), Nevada. This claim was located and the notice of location was posted on 27<sup>th</sup> day of June, 1979.

From the discovery monument, the undersigned claims 1490 feet running in a Northerly direction and 10 feet running in a Southerly direction lengthwise of the claim together with 300 feet in width on each side of the center of the lode or vein. The general course of said lode or vein is from the South to the North. This claim is 1500 feet in length and 600 feet in width.

The discovery monument, at which the notice of location is posted, is located approximately 2,880 feet North and 9,937 feet West from the Southeast Corner of Section 15 T. 23 N, R. 51 E, M.D.B.& M., and said claim is located within the NW 1/4, 1/4, 1/4, 1/4, of Section(s) 16 T. 23 N, R. 51 E, M.D.B.& M.

The surface boundaries of this claim are marked upon the ground as follows: Beginning at the discovery monument and running thence South, 10 feet along the centerline of said claim to a point for the center of the South end line, the true point of beginning, thence
