Notice is hereby given that PHELPS DODGE CORPORATION, whose address is 1601 Vassar Street, Reno, Nevada 89502, by its undersigned agent, makes this location of the BAR No. 65 lode mining claim in the Unknown Mining District Eureka County(ies), Nevada.
