Notice is hereby given that PHELPS DODGE CORPORATION, whose address is 1601 Vassar Street, Reno, Nevada 89502, by its undersigned agent, makes this location of the BAR No. 82 lode mining claim in the Unknown

Mining District Eureka County(ies), Nevada. This claim was located and the notice of location was posted on 27<sup>th</sup> day of June, 1979.

From the discovery monument, the undersigned claims 1490 feet running in a Northerly direction and 10 feet running in a Southerly direction lengthwise of the claim together with 300 feet in width on each side of the center of the lode or vein.
