

CERTIFICATE OF LOCATION LODE MINING CLAIM (NEVADA)

Mining District Eureka County(ies), Nevada. This claim was located and the notice of location was posted on 27th day of June, 1979.

From the discovery monument, the undersigned claims 1490 feet running in a Southerly direction and 10 feet running in a Northerly direction lengthwise of the claim together with 300 feet in width on each side of the center of the lode or vein. The general course of said lode or vein is from the North to the South. This claim is 1500 feet in length and 600 feet in width.

The discovery monument, at which the notice of location is posted, is located approximately 2,740 feet South and 9,937 feet West from the Southeast Corner of Section 15 T. 23 N, R. 51 E, M.D.B.& M., and said claim is located within the SW 1/4, 1/4, 1/4, 1/4, of Section(s) 21 T. 23 N, R. 51 E, M.D.B.& M.

If not otherwise specified, there are 7 posts at least 4in. in diameter by 4 1/2 ft. in length set 1 ft. in the ground, one for the discovery monument, one for each of the four corners and one at the center of each side line, which posts or monuments were erected on July 10, 1979.
