

CERTIFICATE OF LOCATION LODE MINING CLAIM (NEVADA)

Mining District Eureka County(ies), Nevada. This claim was located and the notice of location was posted on 27th day of June, 1979.

From the discovery monument, the undersigned claims 1490 feet running in a Northerly direction and 10 feet running in a Southerly direction lengthwise of the claim together with 300 feet in width on each side of the center of the lode or vein. The general course of said lode or vein is from the South to the North. This claim is 1500 feet in length and 600 feet in width.

The discovery monument, at which the notice of location is posted, is located approximately 2720 feet South and 17,017 feet West from the Southeast Corner of Section 15 T. 23 N, R. 51 E, M.D.B. & M., and said claim is located within the NE 1/4, SE 1/4, 1/4, 1/4, of Section(s) 19 T. 23 N, R. 51 E, M.D.B. & M.
