Notice is hereby given that PHELPS DODGE CORPORATION, whose address is 1601 Vassar Street, Reno, Nevada 89502, by its undersigned agent, makes this location of the BAR No. 146 lode mining claim in the Unknown

Mining District Eureka County(ies), Nevada. This claim was located and the notice of location was posted on 28<sup>th</sup> day of June, 1979.
