

CERTIFICATE OF LOCATION LODE MINING CLAIM (NEVADA)

Mining District Eureka County(ies), Nevada. This claim was located and the notice of location was posted on 2<sup>th</sup> day of July, 1979.

From the discovery monument, the undersigned claims 1490 feet running in a Southerly direction and 10 feet running in a Northerly direction lengthwise of the claim together with 300 feet in width on each side of the center of the lode or vein. The general course of said lode or vein is from the North to the South. This claim is 1500 feet in length and 600 feet in width.

The discovery monument, at which the notice of location is posted, is located approximately 2860 feet North and 6,397 feet West from the Southeast Corner of Section 15 T. 23 N, R. 51 E, M.D.B. & M., and said claim is located within the NE ¼, SE ¼, ¼, ¼, of Section(s) 16 T. 23 N, R. 51 E, M.D.B. & M.

The surface boundaries of this claim are marked upon the ground as follows: Beginning at the discovery monument and running thence North, 10 feet along the centerline of said claim to a point for the center of the North end line, the true point of beginning, thence

If not otherwise specified, there are 7 posts at least 4 in. in diameter by 4 ½ ft. in length set 1 ft. in the ground, one for the discovery monument, one for each of the four corners and one at the center of each side line, which posts or monuments were erected on July 10, 1979.
